## 3. Purposes for which personal data are processed:

- Personal data is processed for the implementation of the membership relationship (e.g. invitation to meetings, collection of dues, organization of sports operations).
- Furthermore, personal data is forwarded to the state professional associations for participation in competitions, tournaments and games.
- In addition, personal data in connection with sporting events, including the reporting of these on the website of the club, in appearances of the social media, as well as on the pages of the professional associations and transmitted to local, regional and national print media.

## 4. Legal bases on which the data processing is carried out:

- As a rule, personal data is processed on the basis of necessity for the performance of a contract pursuant to Article 6 Abs. 1 lit b) DSGVO. The contractual relationships are primarily the membership relationship in the club and participation in the games of the professional associations.
- If personal data is collected without the processing being necessary for the fulfillment of the contract, the processing is based on consent pursuant to Article 6 Abs. 1 lit. A) in accordance with Article 7 DSGVO.
- The publication of personal data on the Internet or in local, regional and national print media is carried out to protect the legitimate interests of the association (see Article 6 Abs. 1 lit. f) DSGVO).

The legitimate interest of the association is to inform the public by reporting on the activities of the association. In this context, personal data including pictures of the participants are published, for example, in the context of reporting on sporting events of the association.

## 5. The recipients, or categories of recipients of the personal data:

- Personal data of members who participate in the games and competitions of the state professional associations will be forwarded to the respective state professional association for the acquisition of a license, a scorecard, a player pass or other eligibility.
- The data of the bank details of the members will be forwarded to the banking institution (Braunschweigische Landessparkasse) for the purpose of collecting the membership fee.

## 6. The duration for which the personal data will be stored or, if this is not possible, the criteria for determining the duration:

- The personal data will be stored for the duration of the membership. Upon termination of membership, the data categories are retained for a further ten years in accordance with the statutory retention periods and then deleted. In the period between termination of membership and deletion, the processing of this data is restricted.
- Personal data required for sending the e-mail newsletter (e-mail address, first name) will continue to be used for this purpose even after termination of membership. This requires a separate unsubscribe at [www.mtv-bs.de/de/Kontakt/Newsletter](http://www.mtv-bs.de/de/Kontakt/Newsletter).
- Certain categories of data are stored in the association archive for the purpose of the association chronicle. These are the categories first name, last name, membership of a team, special sporting successes or events in which the person concerned has participated. The storage is based on a legitimate interest of the club in the contemporary documentation of sporting events and successes of the respective composition of the teams.
- All data of the other categories (e.g. bank data, address) will be deleted upon termination of membership.

## 7. The data subject shall be entitled to the following rights under the conditions stated in each of the articles:

- The right to information in accordance with Article 15 DSGVO,
- The right to rectification in accordance with Article 16 DSGVO,
- The right to removal according to Article 17 DSGVO,
- the right to restriction of processing in accordance to Article 18 DSGVO,
- the right to data portability according to Article 20 DSGVO,
- the right to object in accordance with Article 21 DSGVO,
- the right to lodge a complaint with a supervisory authority pursuant to Article 77 DSGVO,
- the right to withdraw consent at any time without affecting the lawfulness of the processing carried out on the basis of the consent until the withdrawal.

## 8. The source from which the personal data originates:

Personal data is generally collected in the course of acquiring membership.

## Publication of personal images

I hereby consent to the taking of photographs and videos of myself at sporting events (e.g. competitions, shows, training) and for team presentation purposes, and to their publication on the MTV website, social media and in the regional press or for print media.

I have been informed that the photos and videos with my person can be accessed worldwide when published on the internet or in social networks..

Further use and/or modification by third parties cannot be ruled out here. Insofar as the consent is not revoked, it is valid for an unlimited period of time. Consent may be revoked with effect for the future. The revocation of consent must be made in text form (letter or e-mail) to the MTV. A complete deletion of the published photos and video recordings on the Internet cannot be ensured by the MTV, since, for example, other Internet users may have copied or changed the photos and videos. The MTV cannot be held liable for the type and form of use by third parties, such as downloading photos and videos and their subsequent use and modification.

I have also been informed that, despite my revocation, photos and videos may be taken of me in connection with my participation in public events of the MTV and may be published as part of public relations activities.
